ANZ Investments Single-Asset-Class Scheme (marketed as the OneAnswer Single-Asset-Class Funds)

What is the purpose of this update?

This document tells you how the International Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ANZ New Zealand Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The International Fixed Interest Fund invests mainly in international fixed interest assets. Investments may include:

- fixed interest assets issued by government or international companies, and
- cash and cash equivalents.


The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term is in line with the relevant market index.

What are the risks of investing?

Risk indicator for the International Fixed Interest Fund¹:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$156 (that is 1.56% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$156 for the year.


What does the fund invest in?

Notes

- 1. In calculating the risk indicator, a mix of the fund's actual returns and the market index returns have been used. Market index returns have been used for the period 31 December 2012 to 30 September 2013, as the fund began operation on 19 September 2013. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
- 2. The target and actual investment mix of this fund are based on:
- the cash and cash equivalents held by the fund, and
- $\mbox{-}$ the asset class of the underlying fund in which the fund invests.

They are not based on the cash and cash equivalents or any other assets held by the underlying fund.
