What is the purpose of this statement?

This statement provides key information about the OneAnswer KiwiSaver Scheme Cash Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Cash Fund may only invest in overnight deposits and term deposits with one or more New Zealand registered banks. The objectives of the Cash Fund are to:

- Protect the value of investments and provide competitive returns ahead of inflation; and
- Outperform the NZX NZ Bank Bill Index.

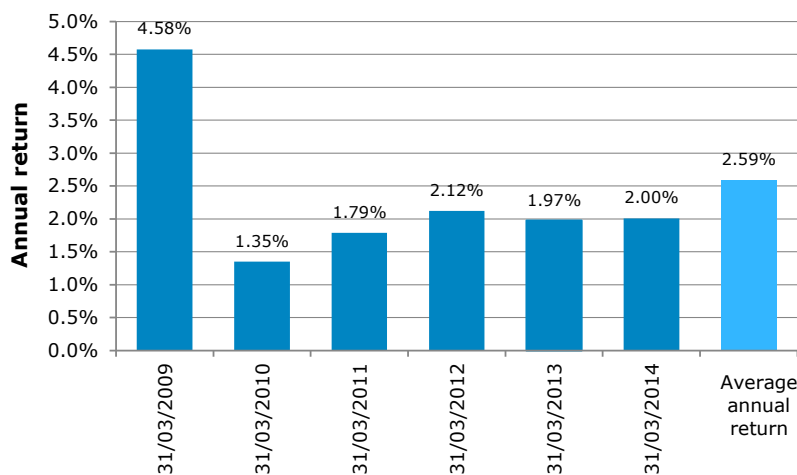

How has the fund performed in the past?

What fees were members charged?

The returns above are after deductions for **fund fees**². These fees were last totalled up for the year to 31 March 2014 and were:

Members were also charged **membership fees**³ of up to \$24 over the year to 31 March 2014.

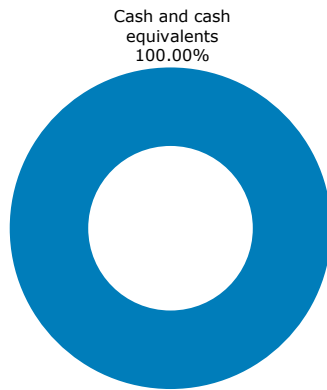
Example of how this applies to a member

Sarah had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Sarah received a return after fund fees and tax were deducted of \$227 (that's 2.27% of her initial \$10,000). Sarah also paid \$24 in membership fees³. This gives Sarah a total return of \$203 for the year.


