What is the purpose of this statement?

This statement provides key information about the OneAnswer KiwiSaver Scheme Cash Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The objective of the Cash Fund is to outperform the NZX NZ Bank Bill Index. The Cash Fund invests mainly in cash assets.

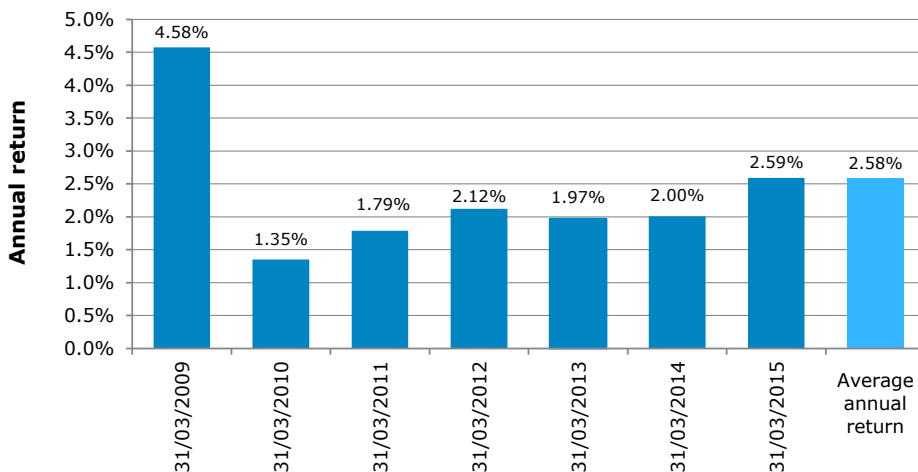

How has the fund performed in the past?

Members were also charged **membership fees**³ of up to \$24 over the year to 31 March 2015.

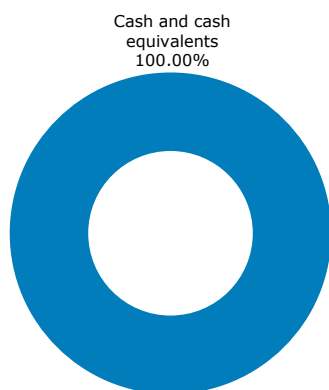
Example of how this applies to a member

Sarah had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Sarah received a return after fund fees and tax were deducted of \$252 (that's 2.52% of her initial \$10,000). Sarah also paid \$24 in membership fees³. This gives Sarah a total return of \$228 for the year.

² Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance). From 17 September 2015 the management fees reduced from 0.50% to 0.48%.

³ Membership fees are the fixed dollar charges for membership in the KiwiSaver scheme. We may, generally or in respect of any particular member, waive part or all of any fee payable to us.


