What is the purpose of this statement?

This statement provides key information about the OneAnswer KiwiSaver Scheme Australasian Property Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Australasian Property Fund invests mainly in an actively managed portfolio of New Zealand and Australian property assets. It may also invest in convertible securities and cash assets. The objectives of the Australasian Property Fund are to:

- Generate competitive returns by investing directly or indirectly in a diversified portfolio of Australasian property assets; and
- Outperform the S&P/NZX All Real Estate (Industry Group) Gross (with Imputation Credits re-invested).

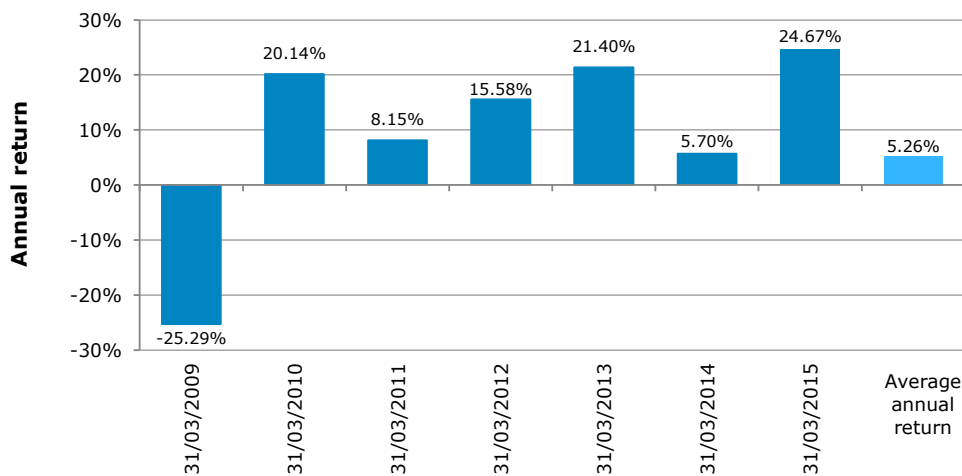

How has the fund performed in the past?

Members were also charged **membership fees**³ of up to \$24 over the year to 31 March 2015.

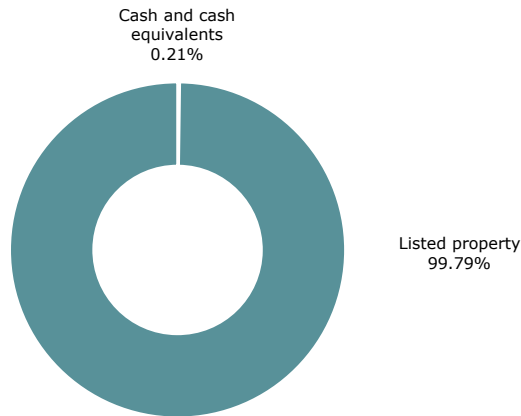
Example of how this applies to a member

Sarah had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Sarah received a return after fund fees and tax were deducted of \$1,281 (that's 12.81% of her initial \$10,000). Sarah also paid \$24 in membership fees³. This gives Sarah a total return of \$1,257 for the year.
