

## OneAnswer KiwiSaver Scheme

### International Property Fund

#### What is the purpose of this statement?

This statement provides key information about the OneAnswer KiwiSaver Scheme International Property Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

#### Description of the fund

The International Property Fund invests mainly in an actively managed portfolio of international property assets. It may also invest in cash assets. The objectives of the International Property Fund are to:

- Generate competitive returns by investing directly or indirectly in a diversified portfolio of international property assets; and
- Outperform the UBS Global Property Total Return Index (ex NZ and Australia) (100% hedged to the New Zealand Dollar).

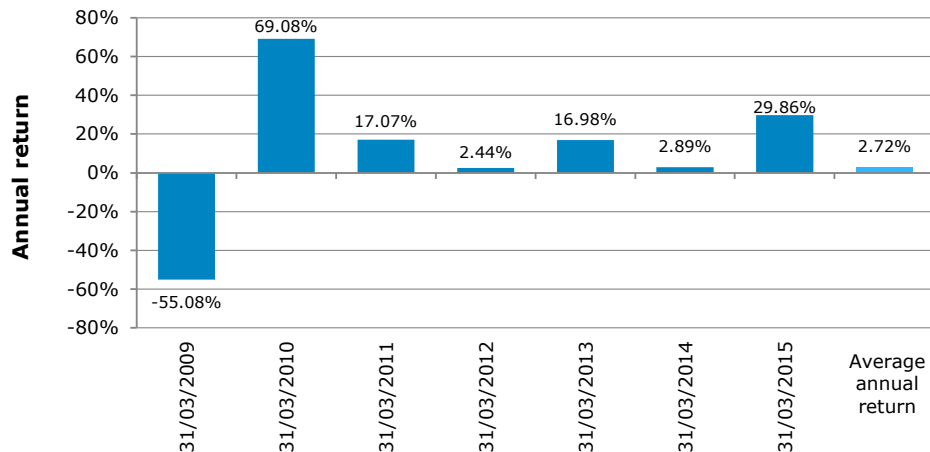

#### How has the fund performed in the past?

Members were also charged **membership fees**<sup>3</sup> of up to \$24 over the year to 31 March 2014.

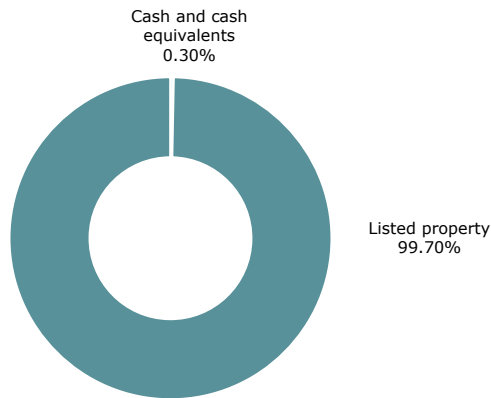
### Example of how this applies to a member

Sarah had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Sarah received a return after fund fees and tax were deducted of \$2,986 (that's 29.86% of her initial \$10,000). Sarah also paid \$24 in membership fees<sup>3</sup>. This gives Sarah a total return of \$2,962 for the year.
