

## OneAnswer KiwiSaver Scheme

### **New Zealand Fixed Interest Fund**

#### What is the purpose of this statement?

This statement provides key information about the OneAnswer KiwiSaver Scheme New Zealand Fixed Interest Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

#### Description of the fund

The New Zealand Fixed Interest Fund invests mainly in three actively managed portfolios of New Zealand fixed interest assets. It may also invest in fixed interest assets issued in New Zealand by international companies, international fixed interest assets (fully hedged back to the New Zealand Dollar) and cash assets. The objectives of the New Zealand Fixed Interest Fund are to:

- Generate steady returns that preserve investment values; and
- Outperform the NZX Government Stock Gross Index.

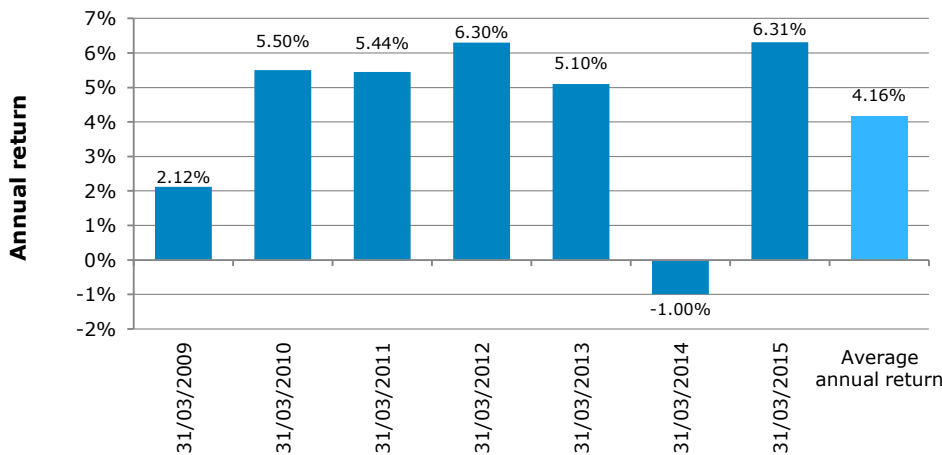

#### How has the fund performed in the past?

The returns above are after deductions for **fund fees**<sup>2</sup>. These fees were last totalled up for the year to 31 March 2014 and were:

Members were also charged **membership fees**<sup>3</sup> of up to \$24 over the year to 31 March 2014.

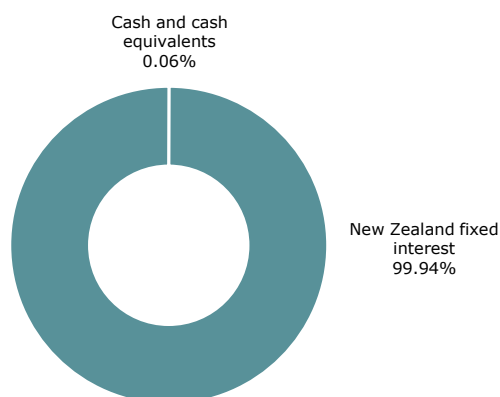
### Example of how this applies to a member

Sarah had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Sarah received a return after fund fees and tax were deducted of \$631 (that's 6.31% of her initial \$10,000). Sarah also paid \$24 in membership fees<sup>3</sup>. This gives Sarah a total return of \$607 for the year.

<sup>2</sup> Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance). From 19 September 2014 the management fee decreased from a maximum of 0.75% to a maximum of 0.55%.

<sup>3</sup> Membership fees are the fixed dollar charges for membership in the KiwiSaver scheme. We may, generally or in respect of any particular member, waive part or all of any fee payable to us.
