

## OneAnswer KiwiSaver Scheme

### International Fixed Interest Fund

#### What is the purpose of this statement?

This statement provides key information about the OneAnswer KiwiSaver Scheme International Fixed Interest Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

#### Description of the fund

The International Fixed Interest Fund invests mainly in up to two actively managed portfolios of international fixed interest assets, as well as cash assets. The objectives of the International Fixed Interest Fund are to:

- Generate steady returns that preserve investment values; and
- Outperform the JP Morgan Global Government Bond Index (100% hedged to the New Zealand Dollar).

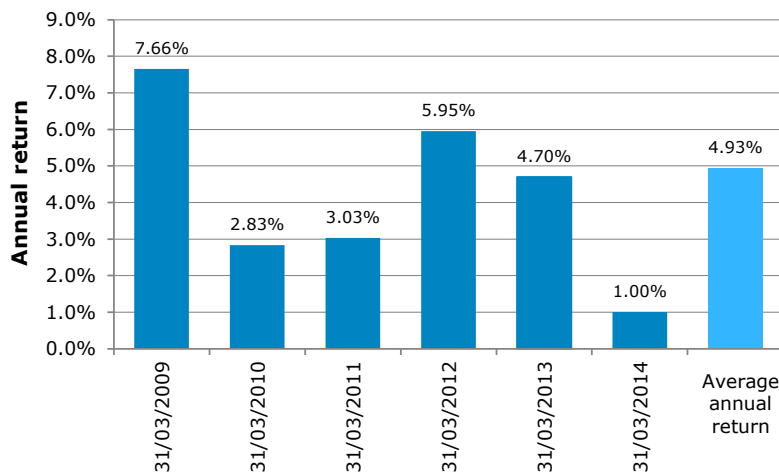

#### How has the fund performed in the past?

#### What fees were members charged?

The returns above are after deductions for **fund fees**<sup>2</sup>. These fees were last totalled up for the year to 31 March 2014 and were:

Members were also charged **membership fees**<sup>3</sup> of up to \$24 over the year to 31 March 2014.

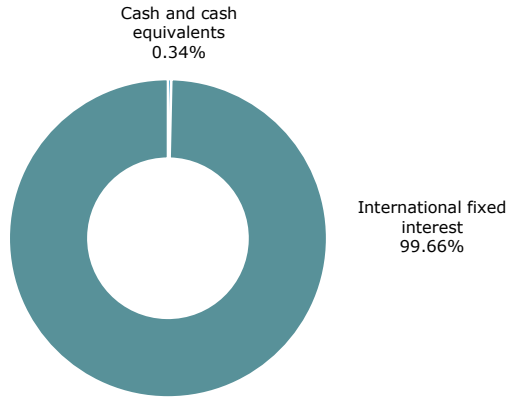
### Example of how this applies to a member

Sarah had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Sarah received a return after fund fees and tax were deducted of \$724 (that's 7.24% of her initial \$10,000). Sarah also paid \$24 in membership fees<sup>3</sup>. This gives Sarah a total return of \$700 for the year.
