What is the purpose of this statement?

This statement provides key information about the OneAnswer KiwiSaver Scheme Sustainable Growth Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Sustainable Growth Fund invests mainly in a diversified portfolio of share assets in companies pursuing a sustainable development policy and combining respect for social principles (such as human rights, non-discrimination and the issue of child labour) and environmental principles with good financial prospects. It may also invest in cash assets. The objective of the Sustainable Growth Fund is to outperform the MSCI World Index (NZ\$).

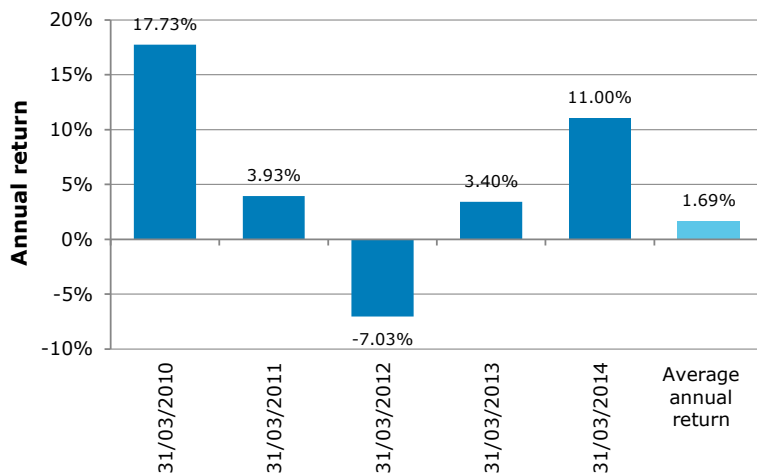

How has the fund performed in the past?

Members were also charged **membership fees**⁴ of up to \$24 over the year to 31 March 2014.

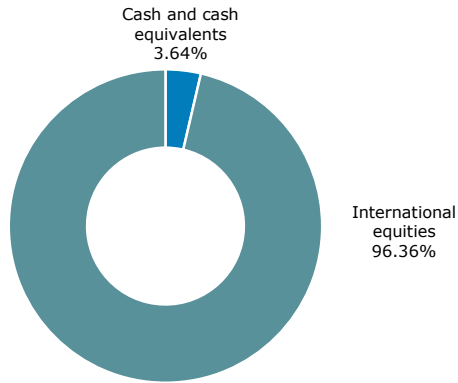
Example of how this applies to a member

Sarah had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Sarah received a return after fund fees and tax were deducted of \$1,100 (that's 11.00% of her initial \$10,000). Sarah also paid \$24 in membership fees. This gives Sarah a total return of \$1,076 for the year.

³ The Manager anticipates that the fund fees incurred for the twelve months ended 31 March 2014 (as a percentage of the net asset value of the fund) will be lower than the fund fees for the period to 31 March 2013. It is anticipated that other fees and costs will be lower because fund expenses have fallen as a percentage of the fund's value in the twelve months ended 31 March 2014.
